CIRCULAR

 Management has accorded approval for renewal of the existing Students Group Accident Policy for the academic year 2023-24.

This is an unnamed policy and the Company does not require the name of each & every student and the staff member. The Company requires only total number of students and the staff members. The premium amount shall be collected only from the students during admission time along with fees as per the category mentioned below. The staff members (both teaching & non-teaching) are covered free of cost.

II. The students & staff members proposed to be covered under THREE categories of grouping of Institutions are as follows.

'A' CATEGORY: Medical College, Dental College & Pharmacy College (2 No's).

'B' CATEGORY: Para Medical, Physiotherapy College, Nursing College, Law

College, Ayurveda Medical College, Speech & Hearing

Colleges and Engineering Colleges, CMS.

'C' CATEGORY: Nursing Schools, Degree Colleges, Polytechnics, ITI's, B.Ed

Colleges, Lab Technician Courses, INYS, PU Colleges and

D.Ed Colleges.
